In accordance with the Government's Federal Accountability Act, Kings-Hants Conservative Association accepts contributions from individual Canadian citizens or permanent residents to a maximum of \$1725 per calendar year.

Tax receipts can only be issued in the name of the contributor and the contributor is considered to be the holder of the credit card or the signatory on the cheque. Please note that contributions from corporation, labour unions or associations, and unincorporated associations are prohibited by Elections Canada.
